

LEGAL BASIS FOR THE 5th INTERNATIONAL SMOKED PAPRIKA POWDER "LA CHINATA" RECIPES CONTEST

OBJECT OF THE CONTEST

1. ORGANIZING COMPANY

2. CONTEST MECHANICS

2.1 Participants

- -Any person, over eighteen, who is the original author of the sent recipe, text, and pictures, will be able to participate.
 - -Each participant will be able to send a maximum of two recipes.
- -The organizers of the contest reserve the right to turn down the participation of users who send fraudulent data about their identity (name, age, address, e-mail...), or who violate the criteria of the restraint policy.
- -The participation in the contest of the NETASA employees and its relatives (family until second next of kin) is excluded.

2.2 Mechanics

- Development of the elaboration
- Photography of the finished recipe in which at least one container of our products must appear. The pictures from the elaboration process will be accepted and appreciated as well.

The only condition for the recipes to be accepted is that one of the ingredients must be one of the following products:

- 1- Smoked Paprika Powder "La Chinata", in any of our three varieties (Sweet, Bitter-Sweet or Hot), and any of our formats (bags or tins). The PREMIUM range can be also used.
- 2- Smoked Paprika Flakes "La Chinata", in any of our three varieties (Sweet, Bitter-Sweet or Hot).
- 3- **Smoked Dried Peppers "La Chinata",** in any of our three varieties (Sweet, Bitter-Sweet or Hot).
